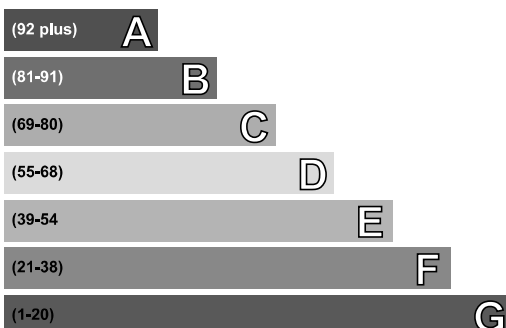

Energy Efficiency Rating

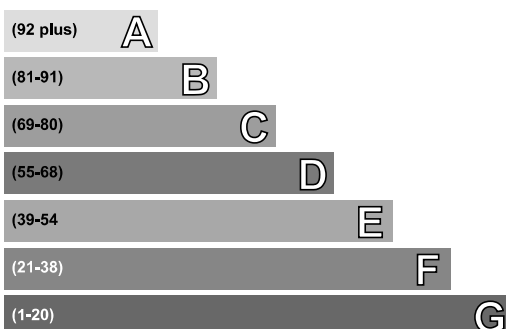
